

RESOLUTION TO AMEND 2025 BUDGET
ACC METROPOLITAN DISTRICT

WHEREAS, the Board of Directors of the ACC Metropolitan District adopted a budget and appropriated funds for the fiscal year 2025 as follows:

General Fund	\$	158,024
Debt Service Fund	\$	1,115,057
Capital Projects Fund	\$	181,000

WHEREAS, the necessity has arisen for additional expenditures in the Debt Service and requiring the unanticipated expenditure of funds in excess of those appropriated for the fiscal year 2025; and

WHEREAS, the expenditure of such funds is a contingency which could not have been reasonably foreseen at the time of adoption of the budget; and

WHEREAS, funds are available for such expenditures in the Debt Service from loan proceeds; and

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the ACC Metropolitan District shall and hereby does amend the adopted Budget for the fiscal year 2025 and adopts a supplemental budget and appropriation for the Debt Service Fund and for the fiscal year 2025, as follows:

BE IT FURTHER RESOLVED, that such sums are hereby appropriated from the revenues of the District to the proper funds for the purposes stated.
